### **Commissioned Services 2023-2024**

#### Sexual Health




Healthy Living Partnership Ltd has continued to manage sexual **Health Service** health services in Essex, excluding Thurrock and Southend.

The service covers the provision of emergency hormone contraception (EHC) to women aged 19 and under, and the provision of chlamydia treatment via PGD.

127 pharmacies have a signed contract to provide the sexual health service in Essex, however only 29 pharmacies have provided EHC advice or provided products.

During 2023-2024, a total of 143 consultations took place. Emergency hormone contraception (EHC) were supplied in majority of cases, 98 (67.1%) Levonorgestrel and 45 (30.5%) Ulipristal, there were 3 cases where no treatment was required.



Total cost of products supplied was £1,375.85

69 community Pharmacies have distributed 638 packets of condoms via the service using a smartphone app Ec-Card.

### **HPV Vaccine Service**

Nine pharmacies continue to be commissioned to offer the MSM HPV vaccines. During the year, there was one 1st vaccines, 43 2nd vaccines and one 3rd vaccines administered.

#### **MPOX Vaccine Service**

The MPOX vaccine service was stood up in response to the 2022 outbreak and stopped in July 2023, prior to this date the 3 pharmacies that had been commissioned administered 346 vaccines. Our MPOX vaccine pharmacies were the only pharmacies in England providing this service.

### Southend Sexual Health Service

Sexual health Service in Southend went live in June 2023, 9 pharmacies were commissioned to deliver the sexual health service in Southend, only 2 pharmacies did provide consultations and issued products to 5 people during December 2023 to March 2024.

## Other locally commissioned services

### Mid and South Essex Palliative Care Service

The service provides immediate access to palliative care medication. 9 pharmacies (listed below) across Mid and South Essex (MSE) continue to be commissioned to hold an agreed list of specialist medication to supply on receipt of a prescription.


### North East Essex End of Life Service

### Thurrock Council Occupational Health Flu vaccination service



As part of the locally commissioned services with Thurrock Council, all council staff are offered to receive the influenza vaccination. Husain Master from Essex Pharmacy spent a couple of days at Thurrock Council office in October 2023 vaccinating staff against the flu, 55 staff members received the vaccine, who would not have been eligible under the NHS criteria and 9 that did meet the criteria.

This data shows the age range for the individuals that benefited from this service at Thurrock Council.

This was the final year of a 5 year contract with Thurrock Council.

### **Gypsy and Traveller sites - Thurrock**

Mo Raje continued to visit the traveller and gypsy community in the Thurrock area. He assisted with medication, including reviews, explaining how to recognise medications and checked blood pressure. These visits concluded in February 2024

### Other involvement

### Mid and South Essex Integration and Resilience Fund

Healthy Living Partnership Ltd worked with Mid and South Essex Integrated Care Board in the administration of a Community Pharmacy Integration and Resilience fund.

It was a one-off payment of £1,500 to offset some of the additional costs that pharmacies incurred relating to medicines shortages, business continuity planning and Primary Care Network/Practice engagement such as promoting advanced services.

The LPCs across the East of England all agreed that there should be minimum administration or monitoring attached to this funding, therefore there is a high degree of trust that contractors will adhere to the terms in the Memorandum of Understanding.

### **Training and Development**

Healthy Living Partnership commission face to face vaccination training during 11th and 25th June in Colchester and Brentwood (4 sessions in total) and a total of 37 contractors attended.

### **Meetings/Events**

19 meetings/events in total have taken place for Contractors, these have covered various topics, including respiratory cardiovascular pathways engagement event, BeNEER joint working meetings and a series of Tackling SABA overuse across the County presented by Sanjeev Rana. Grays Primary Care Network (PCN) Hypertension meeting at Masons in Brentwood, this event was very well attended and included multi disciplinary team members. A couple of meetings specifically for Benfleet and Rayleigh Pharmacy teams as part of the lipids health inequalities project and of course the Pharmacy First Event that took place in March 2024.

### **Pharmacy First Service Development Day**

Due to the high demand for training Healthy Living Partnership hosted a Pharmacy First Service Development Day on Sunday 24th March 2024.

During the day there were 2 sessions led by CPPE covering the practical element of the ears, nose and throat (ENT) training, with each delegate using an otoscope to gain hands on use of the equipment.

In addition there was also a session providing an overview of the Pharmacy First Service, so that pharmacy teams could understand service detail and consider practical elements of service delivery.

Nearly 100 delegates attended the development day.

There was also a contraception workshop delivered by Provide CIC, to build pharmacist competence and confidence in delivering both elements of the community pharmacy contraception advanced service.

### Notes to the Financial Statements for the Year Ended 31 May 2023

#### 1. STATUTORY INFORMATION

Healthy Living Partnership Limited is a private company, limited by shares, registered in England and Wales.

The company's registered number and registered office address can be found on the Company Information page.

The company is not part of a group.

#### 2. ACCOUNTING POLICIES

Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

#### **Turnover**

Turnover represents invoiced sales of services and membership fees received. The company is not VAT registered.

Financial instruments

The company only enters into basic financial instrument transactions that result in the recognition of financial assets and liabilities like trade and other debtors and creditors and investments in ordinary shares.

#### **Taxation**

Taxation for the year comprises current and deferred tax. Tax is recognised in the Income Statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity.

Current or deferred taxation assets and liabilities are not discounted.

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

#### **Deferred** tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Timing differences arise from the inclusion of income and expenses in tax assessments in periods different from those in which they are recognised in financial statements. Deferred tax is measured using tax rates and laws that have been enacted or substantively enacted by the year end and that are expected to apply to the reversal of the timing difference.

Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

### Significant judgements and estimates

No significant judgements or estimations have been applied in the preparation of the financial statements.

#### **Debtors**

Short term debtors are measured at transaction price, less any impairment.

#### **Creditors**

Short term creditors are measured at the transaction price.
