More pharmacies have been signing up to deliver the Essex Community Pharmacy Lifestyle Services, therefore being able to offer the stop smoking, sexual health and NHS health checks to members of public within their local community. This service is available to all pharmacies in the Essex County Council footprint, sorry this service is not yet commissioned in Southend or Thurrock.

Supervised Consumption Service

Essex STaRS hold the contract for the Supervised Consumption Service, however Healthy Living Partnership is supporting recording, reporting and payments for the services.

PocDoc Cholesterol Testing



PocDoc cholesterol kits can be used as part of the NHS Health Check service offer. We have more than 20 pharmacies who are actively using these kits, and we are told they are very straighforward to use.

If you would like to know more about PocDoc, and how you can buy the kits at a discounted rate as part of our partnership working with PocDoc, we are holding a training webinar on Wednesday 26th February 2025. The joining

PocDoc cholesterol kits are available to ALL Essex pharmacies, those pharmacies in Thurrock and Southend on Sea can use them as part of any relevant private services they may offer.



Community Pharmacy Essex (Essex LPC) is also working with Mid and South Essex ICB to look at other opportunities for cardiovascular outreach work, including community based cholesterol testing.

Varenicline

The new PGD to supply Varenicline has now been signed and available to use. This PGD allows registered technicians as well as pharmacists to support smokers to quit smoking.

The PGD is already available on PharmOutcomes on T1 Registration (limited to a maximum of 12 weeks supply). Work is taking place to develop a separate platform, in the meantime if you have patients using Varenicline please record on PMR making sure you keep a record of supply.

Totally Wicked - Vaping

Lisa Lovell has been working hard with Provide CIC and Totally Wicked and we are pleased to finally say that the pharmacy Totally Wicked guidance, checklist and the bulk order form has been circulated to the first group of pharmacies.

Each pharmacy enters name and address and sends their own order via email to Totally Wicked, for either a standard 8 week programme OR for clients on the 12 week "Cut Down To Stop" (CDTS) programme.

Essex County Council – Healthy Living Pharmacy Champion L2/3 Programme

27 pharmacies are now actively participating in this programme. Pharmacies agree to deliver the locally-commissioned stop smoking service, sexual health service, NHS health checks AND substance misuse services, as well as the NHS Contraception advanced service, NHS Hypertension case-finding advanced service and NHS seasonal 'flu vaccination advanced service. The programme aims to better integrate the services from local and national commissioners, so that patients can access the care they need in one place, regardless of who commissioned the activity.

Southend Sexual Health Service
